1. Exact per quarter fee is \$237.66; \$237 is charged in Fall Quarter and \$238 is charged in Winter and Spring quarters.

2. Exact per quarter fee for resident graduates is \$965.33; \$965 is charged in Fall and Spring Quarters, and \$966 is charged in Winter Quarter. Exact per quarter fee for resident undergraduates is \$905.33; \$905 is charged in Fall and Spring quarters, and \$906 is charged in Winter Quarter. Exact per quarter fee for all other students is \$1,028.66; \$1,028 is charged in Fall Quarter and \$1,029 is charged in Winter and Spring quarters.

3. Exact per quarter fee is \$37.66; \$37 is charged in Fall Quarter and \$38 is charged in Winter and Spring quarters.

4. Exact per quarter fee for graduate students is \$3710.66; \$3710 is charged in Fall Quarter and \$3711 is charged in Winter and Spring quarters. Exact per quarter fee for undergraduate students is \$3924.66; \$3924 is charged in Fall Quarter and \$3925 is charged in Winter and Spring quarters. Nonresident tuition for graduate students advanced to doctoral candidacy is \$927 in Fall Quarter and \$928 in Winter and Spring quarters. The reduced fee is applicable for a maximum of nine quarters.

5. Exact per quarter fee for D.D.S. students is \$1,666.66; \$1,666 is charged in Fall Quarter, and \$1,667 is charged in Winter and Spring quarters.

6. For Theater, Film, and Television students, the exact per quarter M.F.A. program fee is \$666.66; \$666 is charged in Fall Quarter, and \$667 is charged in Winter and Spring quarters. The fee for Law students applies only to the J.D. degree program. The fee for Medicine students applies only to the M.D. degree program.
